NOW THIS AMENDMENT TO THE TRUST DEED WITNESSETH

The Board of trustee by its resolution by 2/3rd majority of total members of trust has made the following amendment for smooth running of trust in accordance with law the amendments as follows.

1. Sri Ashok S/o.Bassayya Mustajar has been voluntarily retired from the trust. AND whatever the loan received from Sri Ashok S/o Bassayya Mustajar to the Trust That the Loan and Interest as per Income Tax 1961 has been settled and the whole amount is received by the Sri Ashok S/o Bassayya Mustajar on 01/06/2015.

Now onwards Sri Ashok S/o Bassayya Mustajar is not having any right to claim any benefit or any loss from the Trust in the above mentioned trust as a Trustee or as a treasurer.

- 2. Sri Srinivas S/o.Brahmayya Kasoju he has resigns from Joint Secretary & he has elected as a Treasurer of the trust.
- 3. Smt Sattyamma W/o.Mukundareddy she has been resign from vice president & she has elected as a Joint Secretary of the trust.

NOW THIS DEED WITNESSETH AS UNDER:

- 1. Name of the Trust shall be "VISHWADHAMA EDUCATIONAL & CHARITABLE TRUST, SEDAM", At: Sedam, Dist: Gulbarga (Karnataka). However the board of trustees may shift the office to any other place for their convenience.
- 2. The trust shall function within country of India.

AIMS AND OBJECTIVES:

The aims and objectives of the trust shall be as under:

a) To establish and run residential and non residential educational institutions to impart formal education from the Pre-School level to post graduate level. This would include general school education, general degree and postgraduate degree, programmers, vocational training, technical, education programmers and professional degree programmers.

To establish, construct and maintain auditorium/s function halls under the trust.

3. To ensure day-to-day Pooja, Archana, The celebration of important festivals, etc., in the temple so constructs and maintain.

5. To arrange religious, philosophical and spiritual course, study circles, seminars etc., by inviting the eminent speakers and scholars etc.

6. To establish promote, take over, associate with and run and manage educational medical and other charitable institutions such as Nursery, Primary and high school and colleges in the medium of Kannada, Hindi, English or any other languages.

- 7. To establish educational, charitable and welfare institutions and to run the Educational Institutions, colleges, schools, Hospitals, Libraries, Nursing Schools, Nursing training center, Provide Medical, Technical, Construct Temple and all acts of Charitable Community Hall, Homeopathic and Vocational and profession education and training institutions, Computer training and educational courses of all nature mentioned above such as B.Ed. college, D.Ed. - 16. For any of the purposes aforesaid to procure the assistance of Qualified instructors, Teachers, Professors, Artist, Medical Practitioners and Lawyers both voluntary or otherwise.

To build, construct and maintain houses or other buildings and alter, extend, improve, repair, enlarge, or modify the same including any existing buildings and equip the same with light, water, drainage, furniture, fittings, instruments, apparatus and appliances and all other necessary for the use to which each building is to be put up or held.
- 21. To construct or otherwise acquire, layout, repair, extend, alter, enlarge improve and use any land, recreation or pleasure grounds, parks and any other immovable property belonging to or held by the trust.
- 22. To make such steps by personal or written appeals, exhibitions, public meetings, entertainments or otherwise as may from time to time be deemed expedient for the purpose of procuring contributions to the funds of the trust in the shape of Donations, Legacies, Annual payments or otherwise.
 - To print, publish and exhibit any books, pamphlet or posters that may be considered, described for the promotions and objects of the trust.
 - To sell, manage, transfer, exchange, mortgage, demise, dispose off or otherwise deal with any property whatever belonging to the trust.
 - To give pensions, gratuities or charitable aid to the teachers, staff and other employees or ex-employees of the trust or their wives, children's or other relatives or dependents to make payments towards insurance and to form and contribute to provident and benefit funds for the benefit of any persons employed by the trust of the wives, children's or other relatives or dependents of such persons.
 - To borrow and raise moneys with or without security or in the security mortgage, charge, or Hypothecation or pledge over all or any of the immovable or movable properties belonging to the trust or in any other manner whatever.

INVESTMENT:

The funds of the Trust shall be invested in the modes specified under provisions of Sec. 13 (1) (d) read with Sec. 11 (5) of the Income Tax Act 1961, as amended from time to time.

BOARD OF TRUSTEES:

- 1. There should six trustees including President in the Board of Trustees, whose names are mentioned above. The said board of trustees shall be for life unless they resign or nominate from well wishers like minded people and they shall be given membership as the trustees in their places, with the consent of the President the decision of the quorum will be final.
- 2. The board of trustees shall constitute a President, Vice Presidents, General Secretary, Joint Secretary, and Treasurer among the above trustees.
 - The trustees shall elect among themselves President, Vice Presidents, General Secretary, Joint Secretary, Treasurer and many executive body member. 6. That any trustees who is desirous of seeking discharge from trust may send his resignation to the president three months in advance and the trust may discharge such trustees if he/she is not found due or liable to trust on any of his duty or liability owing to trust.

- 3. He shall have the powers to utilize Rs.3,000/- for urgent expenditure up to Rs.5,000/- he should get the permission of the President, above Rs.10,000/- he may get the sanction from the board of trustees by calling emergent meeting if necessary.
- 4. The Secretary shall look after all the legal matters in respect of the trust and property of the trust.

JOINT SECRETARY:

In the absence of General Secretary the Joint Secretary has got powers, which are conferred with the General Secretary.

He shall keep all the records up to date pertaining to the money transactions and assist the General Secretary.

TREASURER:

The treasurer has got power of Bank transactions and money matter. He shall keep all the money records up to date pertaining to the money transactions and assist the General Secretary.

AMENDMENT TO THE DEED OR TRUST:

The Board of trustees by its resolution by 2/3rd Majority of the total member of the trust shall have the power to change, amend, modify or alter and in the deed of trust, its term and clauses for smooth running of a trust in accordance with law from time to time but such changes or alterations and amendments shall not alter in any way the nature and character of the trust.

FINANCIAL YEAR:

The financial year of the money transactions of the trust shall be the end of March of each British calendar year i.e., 1st April to 31st March of every succeeding year.

CESSATION OF TRUSTEESHIP:

- 1. By the Death of Trustee.
- 2. By resignation duly accepted by the Board of Trustee.
- 3. By expulsion as per clause mentioned above.
- 4. Cessation of trusteeship for any reasons shall not entitle any trustee or any person for the refund of any money paid by him or returns of any donations or gifts etc., made to the trust.

DISSOLUTION:

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustee of Governing Body but the same shall be transferred to another charitable trust whose objects are similar to those of this trust and which enjoys recognition U/s 80 G of the Income Tax Act 1961, as amended from time to time.

GENERAL:

1. The trust created herein shall be irrevocable.

All the deeds and other documents to be executed by or on behalf of the trust shall be done by the Chairman or General Secretary of the trust as per the Registration Act Karnataka Stamps Act 1957 will be applicable in case of such documents. The trust may sue or be sued as per procedure laid down under the Act through its Secretary.

Powers not defined in this deed of trust are vested with the board of trustees in accordance with the existing applicable laws regulations, etc., that may be needed to transits the acts of the trust that come up before them from time to time.

The trust funds shall be invested in such a manner that its income will be exempt under the Income Tax Act 1961.

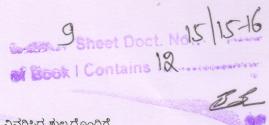

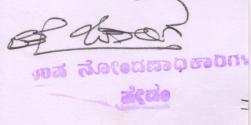
